It's just the beginning of April but car shows and summer activities are just around the corner. It is time to at start making your lists of what needs checked and waxed before this first and done to make your antique vehicle(s) ready for the summer season.

If they are in accessible storage, now might be a good time to make sure the battery is full and if not, then top it off with distilled water. It would be a great idea to hook up a trickle charger now to make sure it is fully charged when you want to get it out - something like a "Battery Tender – Junior" works great. They make them for both 6V and 12V batteries.

Check the tires while vou are still in the garage. If they check low, now is the time to air them up via a compressor or portable air tank before they have a chance to go all the way flat. Next on the list – "make a list": What were the issues you had last year with each car and if not addressed last fall, needs to be done in the Spring. Did the car have a tendency to overheat (think parades...)? Is there a bit of trim or interior work to be done before the Carlson Show. one that you need to search parts for? Remembering Furman Dotson by Don Oines

Bill Yingst passed away on in March 10, 2011, at the age of 80. Bill was a well-known welder in Alaska who had the motto "Have Welding Truck Will Travel." He worked on the Oil Pipeline, and everywhere else he was needed. He was an active member of the Fairbanks VLNAACF for many years.

We traveled under Marshal Law for 10 days escorted by Canadian Mounties and Canadian Military forces. A US postage stamp was also issued to commemorate the event.

It's Spring and Time For a Safety Check

I want to share my "Lesson Learned" with everyone in the club as spring is upon us and we are planning to get our cars out of the garage and on the road. But first, let's look at the accident that I had with my 1930 Model A coupe this past June.

In preparation for the Fountainhead Car Show, club president, Rick Larrick and I made plans to drive my car over the run around route to check out the course and to get the overall time for the event. I departed from home, stopped at the first intersection and turned to go down the hill on Chena Ridge road. As I shifted into high gear the steering wheel suddenly turned freely. MY GOD, I LOST STEERING COMPLETELY! The next minute or two passed very quickly but I as applied the brakes the car immediately started to veer off the road to the grassy shoulder. The brakes locked the wheels but to little effect in the grass and weeds. The car went over the shoulder into the brushy regrowth of small trees and ultimately hit a birch tree which stopped the car. The impact with the bumper broke the tree which then fell on top of the car. I was shook up but fortunately was not hurt by the sudden stop. I immediately got out of the car and inspected the damage. I was devastated because my beautiful car which I have owned for more than 50 years was seriously damaged. I called Willy and Rick at the Antique Auto Museum to tell them that I had a problem and would not be able to do the practice run around. They immediately came to give support to my "weak legs" since I was in a bit of shock yet. They helped me extricate the car and get it back to my garage for which I will be eternally grateful.

Upon inspection it was apparent that a faulty Pitman arm was the cause of the accident. As the photo shows, the ball separated from the arm because it was not properly welded in place. Instead of welding, the ball was essentially glued into place with metal fillet and made to look solid and authentic. This faulty part was purchased more than 20 years ago so I can't recall its origin. When I shopped for a new Pitman arm I called my favorite company and interrogated them about whether they sold one piece casted replacements parts.

It was also evident that the tree hit the bumper at a perfect location to allow the spring steel to absorb a major part of the impact of the collision. The fender was completely totaled and the radiator was twisted but many of the other parts were restorable. The total parts to bring back the car totaled more than \$2000.

Going back to lessons learned, I keep asking myself why I did not inspect the running gear in the spring before I started the cruising season. It is a policy of many car tours to offer a complementary safety check of steering, brakes and spoked wheels. Our club does not have a compulsory safety check but I am now determined that I will inspect my running gear. I just recently completed that inspection for my 57 Cor-

vette and the Model A is next in line.

Another lesson learned— Since I have owned my Model A since I was 15 years old during some lean years I only maintained the required liability insurance. I also did not increase the coverage to include collision insurance after the completed restoration of the car in the early 90's. During recent years the cost of collision insurance for antique autos through special insurance companies is quite reasonable so I no longer view the price of collision insurance as too costly. A cost analysis of replacement parts from the wreck of \$2000 plus a guess for the labor of about \$2000 for a total of \$4000 over 50 years is about \$80/year. This is very close to the annual cost of antique auto insurance hence it is a "no brainer" to add this coverage to protect my investment. I purchased full insurance coverage on my two Corvettes but it is a new realization to me that the remainder of my antiques autos (1917 Model T, 1926 Model T, 1930 Model A and 1972 Fiat Model 124 Spider) should really be fully covered also. So as spring approaches let's get our cars ready for the run arounds by inspecting our cars to make them safe as possible as well as the washing and cleaning to make them shine.
